Presentation: Causes of Hive Loss (and their prevention)

How to recognize a health hive:

- 1. **Colony Condition**-You need lots of bees, about 50,000 bees. You should have several frames of brood. good queen, no late swarm, not week
- 2. **Plenty of surplus of food stores** The amount and proximity of food stores are very important. You should have approximately 60lbs. of honey per hive. (1 full shallow super = 25lb)

It is important to know how to make fondant for two reasons:

- A. If the bees should run out of their food stores, the fondant will give them needed food to survive.
- **B.** During prolonged cold, bees will not break the cluster. They starve in place. Apply fondant directly to the cluster. It can be applied on a cool day if done quickly. ~50° F
- 3. **Cold Conditions** The cluster size and hive strength are very important. You need to control moisture. The condensation can kill the bees. Good ventilation is important.
- 4. Pests and Diseases need to be controlled. i.e. Varroa mite, small hive beetle, Nosema

Virginia BeeCheck

In cooperation with our stakeholders, the Virginia Department of Agriculture and Consumer Services (VDACS) developed Virginia's Voluntary Plan to Mitigate the Risk of Pesticides to Managed Pollinators. The plan is a set of voluntary recommendations and best management practices intended to increase protection of managed pollinators from pesticides while allowing effective control of pests that adversely affect crops, structures, public health and domestic animals. A key component of the plan is timely and voluntary communication and coordination among key stakeholders, including beekeepers and agricultural and commercial non-agricultural pesticide applicators. To facilitate communication between beekeepers and agricultural producers and pesticides applicators VDACS has acquired BeeCheck™, Apiary Registry by FieldWatch®. BeeCheck™ is an on-line tool for mapping apiary locations and providing beekeeper contact information. Hobbyist and commercial beekeepers are encouraged to enroll in BeeCheck™ to provide contact information to pesticide users. Enrollment in BeeCheck™ is voluntary and free; and, monitored by data stewards at VDACS. To enroll in Virginia BeeCheck™ go to http://va.beecheck.org.
